# **Website Enquiry Privacy Notice**

#### Who are we?

# Why do we collect this information?

# What do we do with your information?

We are arranging contractual agreements with Spitfire Network Services Limited and Wimborne Business Systems Ltd that commits them to providing an appropriate level of safeguards for your personal data. It is not sent outside of the European Economic Area (EEA).

We will read your message and normally respond to you either via telephone or via email. We may ask for your consent to retain your information on our computer system in order to send you further information that we think may be of interest to you.

We will not use the information to make any automated decisions that might affect you.

### How long do we keep your information for?

Your enquiry is kept in our computer system for six months unless you give us your consent to send you marketing information on an ongoing basis, in which case we will keep it for as long as you continue to consent or you subsequently instruct us to act for you on a matter arising from your initial enquiry.

#### Your rights over your information

By law, you can ask us what information we hold about you, you can see it, and you can ask us to correct it if it is inaccurate.

You can also ask for it to be erased and you can ask for us to give you a copy of the information.

You can also ask us to stop using your information at any time, either by clicking the unsubscribe link at the end of any email communication, if ever subscribed, or by emailing, writing or telephoning us using the contact details above unless you have subsequently instructed us to undertake legal services for you in which case we will retain the information in accordance with the contract we enter into with you.
